A BILL

To direct the Secretary of Agriculture to provide emergency payments to dairy producers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EMERGENCY PAYMENTS.
- 4 (a) IN GENERAL.—Not later than 60 days after the
- 5 date of enactment of this Act, the Secretary of Agriculture
- 6 (referred to in this Act as the "Secretary") shall issue
- 7 emergency payments to dairy producers according to cri-
- 8 teria developed by the Secretary under subsection (b).
- 9 (b) Criteria.—

1	(1) In General.—The Secretary shall develop
2	criteria for the issuance of emergency payments
3	under subsection (a).
4	(2) Priority.—In developing criteria under
5	paragraph (1), the Secretary shall—
6	(A) give priority to a dairy producer—
7	(i) located in a State with a high cost
8	of dairy production compared to other
9	States; or
10	(ii) on a farm with a high cost of
11	dairy production based on the size of the
12	farm, as determined by the Secretary; and
13	(B) in carrying out subparagraph (A), use
14	the most current estimates of the Economic Re-
15	search Service for the cost of milk production
16	by State and nationwide.
17	(c) PAYMENT LIMITATION.—An emergency payment
18	under subsection (a) shall be not less than $$10,000$ but
19	not greater than \$20,000 per dairy operation.
20	(d) Funding.—Of the funds of the Commodity Cred-
21	it Corporation, the Secretary shall use to carry out this
22	section $$556,000,000$ for fiscal year 2019, to remain avail-
23	able until expended.
