A BILL

- To amend the Internal Revenue Code of 1986 to impose a corporate tax rate increase on companies whose ratio of compensation of the CEO or other highest paid employee to median worker compensation is more than 50 to 1, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - This Act may be cited as the "Tax Excessive CEO 4
 - Pay Act of 2019".

1	SEC. 2. CORPORATE TAX INCREASE BASED ON COMPENSA-
2	TION RATIO.
3	(a) In General.—Section 11 of the Internal Rev-
4	enue Code of 1986 is amended by adding at the end the
5	following new subsection:
6	"(e) Tax Increase Based on Pay Ratio.—
7	"(1) In general.—
8	"(A) Increase imposed.—In the case of
9	any corporation (except as provided in subpara-
10	graph (B)(ii)(II)) the pay ratio of which is
11	greater than 50 to 1 for a taxable year, the 21
12	percent rate under subsection (b) for such tax-
13	able year shall be increased by the penalty de-
14	termined under paragraph (2).
15	"(B) Pay ratio.—For purposes of this
16	subsection—
17	"(i) In General.—The term 'pay
18	ratio' means the ratio described in section
19	229.402(u)(1)(iii) of title 17, Code of Fed-
20	eral Regulations (or any successor there-
21	to), except that if the highest compensated
22	employee of the corporation is not the
23	principal executive officer, the ratio shall
24	be determined based on the compensation
25	of such highest compensated employee.

1	"(ii) Corporations not subject to
2	SEC FILING.—In the case of a corporation
3	which (without regard to this clause) is not
4	subject to the authorities described in sec-
5	tion 229.10(a) of title 17, Code of Federal
6	Regulations (or any successor thereto)—
7	"(I) Large corporations.—If
8	the average annual gross receipts of
9	such corporation for the 3-taxable-
10	year period ending with the taxable
11	year which precedes such taxable year
12	are at least \$100,000,000, such cor-
13	poration shall calculate and report its
14	pay ratio according to the method
15	which the Secretary shall prescribe by
16	regulations consistent with the regula-
17	tion described in clause (i).
18	$``(\Pi)$ Other private corpora-
19	TIONS EXEMPT.—Subparagraph (A)
20	shall not apply to any such corpora-
21	tion if the average annual gross re-
22	ceipts of such corporation for the 3-
23	taxable-year period ending with the
24	taxable year which precedes such tax-
25	able year are less than \$100,000,000.
